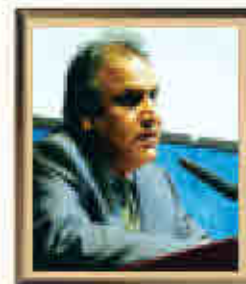

University of Rajasthan: An Overview

University of Rajasthan is a vibrant community of scholars who stand in the service of Rajasthan and that of the country as a whole. The University of Rajasthan holds the distinction of being the oldest institution of higher learning. It was established on January 8, 1947 and recognised since the time of its inception under section 2F and 12 B of UGC Act. Dr. G. S. Mahajani, was appointed as the first Vice-Chancellor of the University. A deep into the past has many interesting features to reveal its progressive and dynamic outlook since its very beginning. The University was

establishing with the main objective of disseminating knowledge and catering to the needs of the students of Rajasthan. The University Motto, "Dharmo Vishwasya Jagatah Pratishtha" suggested by the Vice-Chancellor, Dr. G. S. Mahajani was accepted by the Executive Council at its meeting held on 28-January, 1948. The foundation stone of the University Campus was laid by Shri C. Rajagopalachari on Sunday, the February 20, 1949. He concluded his address on the occasion with these words, "Nothing can be achieved unless we learn to be good and correct and self-disciplined and cultivate self-restraint and that, which is called dharma in our beautiful language." It had jurisdiction over the entire state. With the successive creation of other universities, its affiliating jurisdiction has come down, but it is still the hub of Higher Education in Rajasthan paving the way for the other universities. It attracts students from all over Rajasthan and other parts of India and abroad.

University of Rajasthan is a multi-faculty University. 38 P.G. Teaching Departments are in existence in faculties of Arts, Science, Social Science, Commerce, Law, Management, Fine Arts, Education and Library Science. Admissions to the P.G. Courses offered are based on entrance tests and merit. Some of the P.G. Departments run need-based self-financing courses also. (Many eminent scholars have been teachers at the P.G. Departments. The well-known personalities include: Professors Raja Chelliah, Raj Krishna, L.S. Ramaswami, C.V. Subramaniam, M.V. Mathur, P.N. Srivastava, R.K. Kaul, R.C. Mehrotra, Yogendra Singh, G. Ranganathan, Satish Chandra, Dayakrishna, Om Prakash, Iqbal Narain, G.C. Pande, B.L. Saraf, S. Loknathan, S.P. Verma, C.P. Bhamhri, V. R. Mehta, Y.K. Alagh, C. Rangarajan etc.) 15 recognized Research Centers, 6 Constituent Colleges and 700 Affiliated Colleges spanning 2 districts. The location of the University is Urban and its Central Campus is spread over 285.50 acres and the satellite campus, comprising the Constituent Colleges, is spread over 149.53 acres.

A BRIEF PROFILE OF THE DEPARTMENT OF ECONOMICS

The Department of Economics, established in 1947, is one of the oldest teaching Departments of the University. The Department has integrated economic theory with its practical application since its inception. The Department has distinguished itself in academic and research activities. It has the privilege of being associated with eminent economists of national and international repute such as Late Prof. M.V. Mathur, Late Prof. Raj Krishna, Late Prof. Raja. J. Chelliah, Prof. G.S. Bhalla, Dr. C. Rangarajan, Prof. Y.K. Alagh, Dr. Ramesh Bhatia, Prof. Kanta Ahuja, Prof. M.C. Vaish, Prof. B.C. Mehta, Prof. C.S. Barla, Dr. Arvind Pangariya. At present the Department has a team of 17 vibrant faculty members who shoulder dual responsibility of teaching as well as research. The Department imparts teaching M.A. and Pre-Ph.D./M. Phil course work and also involved in quality research and supervising students for Ph.D. degrees. Each year, about 210 students are admitted in M.A. and 30 students in M. Phil/Ph.D. The Department updated the UG and PG syllabuses during last two years to maintain the national as well as International level. In addition to the compulsory papers like microeconomic theory, macroeconomic theory, international economics, development economics, public finance and quantitative methods in economics, the department provides teaching in elective papers like mathematical economics, econometrics, mathematical statistics, survey methods, health economics, population studies, economics of infrastructure advanced banking agricultural economics, international finance, advanced Indian economy, and environment economics. The department is also associated with teaching at the undergraduate level at the three constituent colleges namely, University Maharaja College, University Rajasthan College and University Maharani College. The Department provides leadership to all the affiliated colleges of the University of Rajasthan. The faculty has been providing assistance to the Government of Rajasthan on the

policy framework.

Recognizing the achievements of the Department and its contribution to the Indian Economy, Planning Commission sanctioned the Planning Commission Chair to the Department in 1996. Another achievement for the Department was signing of MOU between the University and Directorate of Census operations on 28th September, 2012. Directorate of Census Government of India establishes a state level work station to explore the micro data for research purpose in the Department. It disseminates wealth of information in the form of Census data to the academic community and research related activities. The department believes in holistic development of its students; hence gives due importance to extra-curricular activities. The students of MA third semester, with the assistance of the Department, organized a Fresher's party and MA second semester, Farewell party filled with vigor and color for the new students and keep memories of outgoing students. Department organized its Annual Intellectual and Cultural Fest 'ARTHONOMICS' from last two year. As part of its consistent efforts to take learning beyond the classroom, the Department of Economics and the Student Economics society 'Econolibrum' earnestly endeavours to organize several academic, literary and cultural events that provide a platform for students, research scholars and faculty of the institute to simulate solutions to real life economic problems outside of the classroom and encourage extracurricular creativity in multiple dimensions. Since 2019, department also made provision for each year topper student will be entitled to get help an amount of Rs. 5100/- cash. The year 2019 marked its beginning with the enlightened lecture on "International Labour Organization and Decent Work" delivered by Prof. Naren Prasad Senior Economist ILO, Geneva, on 27 February, 2019. The Department continued to provide excellent interaction to its students by organizing lectures, Seminars, symposium and workshops.

**103rd ANNUAL CONFERENCE THEMES**

Overarching Theme : Accelerating Economic Growth, Balanced Regional Development and Sustainable Urbanization in the aftermath of COVID -19

The slowdown of economic growth in recent years has been further compounded by the COVID-19 pandemic making the recovery even more challenging. The economic growth in the past decades has also not been benefiting all the quarters of the economy equally and inequalities have been rising. The banking and financial sector in the country has undergone tremendous stress in the recent times with the collapse of a number of banks and financial institutions. What policy lessons and reforms can be taken to build a robust banking and financial sector for the New India. The challenges of reviving economy in the context of the incipient Fourth Industrial Revolution draw attention to the criticality of human resource development. Finally, India also needs to address the challenges of turning the trend of rapid urbanization into a more sustainable and resilient one. The overarching theme of the 103rd Annual Conference of the Indian Economic Association is designed around five sub-themes covering priority to issues of contemporary national economic importance. The IEA's flagship Annual Economic Conference is featured an engaging programme consisting of keynote paper presentations, panel discussions, endowment lectures, memorial lectures and technical sessions covering the broad themes.

1. Accelerating Economic Growth: Trends and Way Forward

The growth rate of Indian economy has decelerated consistently in the recent years from 7 per cent achieved in 2017-18 to only 5 per cent in 2019-20.

The outlook for economic growth is also clouded by the outbreak of COVID-19 pandemic that has affected all the segments and sectors of the economy. Investment rate, consumption and export growth rates decelerated over time. Gross fixed capital formation as per cent of GDP declined from 34.2 per cent in 2011-12 to 29.0 per cent in 2018-19. Gross domestic savings as per cent of GDP also fell from 34.6 per cent to 30.1 per cent during the same period. Exports have been stagnant around \$300 billion since 2011-12.

The most significant and the fastest growing sector of Indian economy are services, trade, hotels, transport and communication; financing, insurance, real estate and business services and community, social and personal services account for more than 60 per cent of GDP. Agriculture, forestry and fishing constitute around 12 per cent of the output, but employs more than 50 per cent of the labour force. Manufacturing accounts for 15 per cent of GDP, construction for another 8 per cent and mining, quarrying, electricity, gas and water supply for the remaining 5 per cent.

High non-performing assets of banks (NPAs), low credit growth, global factors particularly for trade, non-banking financial companies (NBFCs) problems, low agriculture and rural incomes were responsible for slowdown. Construction sector also showed slowdown. Policies have to be framed to revive private sector investment, consumption and exports. Fiscal and monetary policies of the government should also stimulate growth.

2. Sustainable Urbanisation

For economic transformation, India should prepare for increasing urbanisation and raise quality of living in urban areas. SDGs (Sustainable Development Goals) also include urbanization challenges. The Goal no. 11 of SDGs deal with sustainable cities. Some of the challenges of urbanisation are: creation of adequate urban housing and office space; prevention of slum creation; reducing air pollution, municipal solid waste management; provision of greenery and common spaces for outdoor activity; provision of health, education, nutrition, electricity, water and sewage; and provision of a vibrant transportation system. Migration is another challenge in urban areas.

3. Banking and Financial Sector for New India

The development of efficient banking and financial sector is crucial for economic growth and equity. High non-performing assets of banks (NPAs), low credit growth, problems of non-banking financial companies (NBFCs) are some of the reasons for economic slowdown in the country. India recently completed 50 years of bank nationalization. There has been some consolidation in public sector banking.

NPA's of banks have been increasing particularly since 2013. After demonetisation, banks have to lend to large amounts to NBFCs. They borrowed short term credit and started lending to long term infrastructure and real estate. With the crisis in ILFS (Infrastructure leasing and financial services), there has been liquidity crisis for NBFCs. It led to decline in consumption of the economy. Cooperative banks also faced problems as shown by the recent crisis in Punjab and Maharashtra Cooperative bank. There is a need for better corporate governance in banks, NBFCs and cooperative sector. Information technology should be used for improving efficiency in banking and financial services. The government has taken some steps to revive banking and financial sector including recapitalisation of public sector banks. It also introduced insolvency and banking code which helps in insolvency resolution in a time bound manner. Credit growth for MSME sector also has to be increased. Improvement in financial inclusion also helps the economy.

4. Balanced Regional Development

The widening of inter-regional disparities in recent times has been well recognised. All the earlier five year plans and the present NITI Aayog stressed the importance of balanced regional development. Policies were designed to provide more investments to the relatively backward areas. In spite of these policies, the existence of regional disparities is a serious problem in India. The degree of control of central government declined in many areas due to deregulation in many sectors of the economy. Various finance commissions also encouraged incentives for reduction in regional disparities.

State governments can take more initiatives for economic development now than before. Also, the role of private sector is becoming more important as compared to the public sector. Apart from central government interventions, state level policies are crucial for attracting domestic and foreign investments. The role of public policy is also vital for reducing regional disparities. In this context, it would be interesting to look at changes in inter-state and intra-state disparities and suggest policies for balanced regional development.

5. Human Resource Development in the Context of New Technological Revolution

Providing quality education is the key for raising human development in India. The goal on education under the SDGs requires ensuring inclusive and quality education for all. Improving learning outcomes in education is an important part of this goal. It creates equality of opportunity for all sections of the population. This is also important for reducing labour market inequalities. The government has prepared a new National Education Policy (NEP) for both school and higher education. One needs to examine the policies suggested by NEP. The new education policies also mentions the need for higher public expenditure at about 6 per cent of the GDP on education. The NEP argues for transforming India's higher education system to one of the globally best educational system. It also proposes to establish the National Research Foundation to fund, coordinate and promote research in the country. There is a need to suggest policies for improving quality in both school and higher education.

Technologies are important to improve education and skills of the population. We have to be ready to approach a fourth industrial revolution which includes advanced manufacturing, quantum engineering, 3D printing and robotics. Artificial intelligence and machine learning can improve the quality of education. The new technologies can also raise the skills of the population.

LAST DATE OF SUBMISSION OF PAPERS

Papers must reach latest by 15th January 2021. Papers received after the last date will not be considered for publication in the Special issue of the Indian Economic Journal. Papers submitted by members after the due date may be allowed to present only after getting permission of the Chair.

SIZE OF PAPER AND SUBMISSION PROCEDURE

The paper should be in about 3000 words typed in Times New Roman font 12 in 1.5 space, with an abstract of 500 words. Papers without abstracts will not be considered for publication. Articles should be typed in MS-WORD only. Research Papers on other formats, like pdf will not be considered. Kindly mention your date of birth in your forwarding letter for the easy separation of papers for selecting awards.
